4. Annual Report of CES Activities 2019 – 2020

We at CES have greatly appreciated the strong leadership of Bishop George Browning, recognizing that his high profile and deep insights and contributions have been invaluable over the past dozen years and have accepted his well-deserved retirement from being Chair of CES. Since the last AGM, we had the 2019 dinner and several forums in the latter part of 2019 but during 2020, the program has been severely limited by the COVID-19 pandemic. Our theme for 2020 "Values and Voices in the Public Sphere" began with the comprehensive opening forum by Ken Crispin but the pandemic meant we were then limited to Web Presentations only: a perceptive presentation on "Screen Addiction and the Next Generation" by Toni Hassan as interviewed by Stephen Pickard and the very topical "Australia Post COVID-19" Lyn Hatfield-Dodds interviewed by John Warhurst.

5. Annual Financial Statement 2019 - 2020

The Annual Financial Statement for the period 2019 – 2020 was presented. Jeremy reported that we started the 2019-20 year with \$4944 and with reduced income because of fewer forums, we now have just over \$4000. It was suggested that we send out reminders for membership dues as only a few have paid.
